May Meeting Notes

Monday, May 24, 2021 10:00am – 12 noon via Zoom

A regular meeting of the Environmental – Recreation Committee of the Arkansas Basin Roundtable convened virtually. The meeting was called to order by Bob Hamel, Ark Basin Envi-Rec Chair.

May Meeting Notes:

- 1. Cindy Williams presented on the newly released Chaffee County Rec Plan by first presenting this 6 minute video and a presentation about 'Recreation In Balance' and applications to improve forest health. Greg Felt commented that this plan is transferable and scalable...similar to the wildfire protection plan. It could easily be applied in neighboring counties or areas. Feedback on the plan is due June 4, please visit envisionchaffeeco.org.
- 2. Black Hills Energy site update (Canon City): Bob shared that he met with a representative from Black Hills along with the Canon City Manager and others. An RFP will be coming out soon to improve the site, establish boat ramp access, river walk connections, nature trails, picnic areas, and camping. Work might start in summer 2022. This is an exciting development which ties into reaching out to the Oil Ditch company again on possible safety improvements to their diversion headgate and other related projects.
- 3. CDPHE announced \$7 Million available for upper Ark Restoration projects as part of a Natural Resource Damages claim. For details, go to the <u>official notice here</u>. Application deadline is June 1. Rena announced that CPW intends to apply for funding for the Mt. Shavano Low Head dam project (Maximum cost could be \$3 Million).
- 4. Julie Knudsen (Purgatoire Watershed Partnership) shared that the Purgatoire received some recent rains resulting in big flows (3000+ cfs).

- 5. Misty (USFS) reported San Carlos Ranger District fuels treatments are planned, and the development of landscape maps to understand what's been treated and what needs treatment is desired grant funding needed for this. It's been recently predicted that 75% of high elevation spruce trees will be lost by 2025 due to beetle kill and other causes. USFS is also preparing for another crowded camping season (weekends are now like past holidays and weekdays are like past weekends). Wildfire prep is also underway.
- 6. Bob reported that the VFMP water is still being held up high at 10,000 ac-ft (the usual amount) and it's still too soon to tell how the flows will be managed in July-August.
- 7. Bob asked for further updates, and with none heard, motioned to adjourn the meeting.
