## Environmental & Recreation Committee Purpose and Goals: (see end of document).

#### January Summary:

-Continued discussion on how can we quantify the value of envi/rec projects and how can we set measurable goals & outcomes as a committee.

-Continued discussion on updating the Basin Implementation Plan and updating the IPP list. Many projects on the 2015 list are agency projects (USFS, BLM, CPW). Good first step would be for the agencies to "clean up" or re-evaluate projects. Discussed whether there should be a separate section for multi-stakeholder projects. A contractor will be hired to help with the update effort - that RFQ goes out on March 22.

-TU (Dan Omasta) is drafting grant request to build program to engage stakeholders to elevate smaller restoration projects (i.e. River Watch is one partner).

-It was suggested that Envi/Rec should hire a coordinator to push projects along that need assistance with grant writing.

-Continued discussion on Oil Creek Diversion improvement - acknowledging that it's challenging to push a project forward when one party is unwilling (Oil Creek Ditch Company). Mannie acknowledged that he will work on bringing that party on board.

-Homework for next Envi/Rec meeting is to clean up the old 2015 IPP list as much as possible for the various agencies and share the result.

-Encourage environmental & recreation groups to come to this committee before approaching Needs Assessment Committee or Roundtable. This committee can aid by providing letters of support of certain projects.

-Outreach and education. Continually strive to bring awareness of past, present, and future envi & rec projects.
