- The committee met with Lindsey Griffith on the Basin Implementation Plan.
- Mike Fink will be stepping down as the representative for El Paso County. He has been a member of the Executive Committee as the Recorder for some time. Pikes Peak Regional Water Authority is making a recommendation to El Paso County Commissioners for his replacement.

CWCB Report - Sam Stein - engagecwcb.org

Public Education Public Outreach got a big boost from the state. \$25,000 per basin is now available each year. Please take the BIP Survey: https://www.surveymonkey.com/r/6VFB6Y8

There is a drought leadership training program through CSU Extension, February 4th, 11th, 18th, and March 4th, 8th, 9th, 16th.

IBCC- Jeris Danielson

In a discussion with Jeris, Dan Gibbs pointed out that 2022 will be the year of water. The Colorado River Compact will turn 50, and the Water Plan Update will hit the governor's desk in December. IBCC will continue to discuss demand management in February. Dan Gibbs also wants to look at the long-range evaluation of the privacies role and how to chart a path forward.

Jeris encouraged members to share input on what they would like to see IBCC work on.

Mark suggested that IBCC could work on the conceptual framework as it relates to new trans-mountain diversions and what that phrase means, and suggested discussion on the future of the Water Supply Reserve Fund.

ARWC – Jonathan Paklaian

The fuels mitigation specialist has been hired.

ARWC is planning for 2022, there will be lot of work in middle Arkansas Basin in the Wet Mountains.

The Monarch project is complete and ARWC had an after-action review with the Forest Service to discuss what could be improved.

ARWC received a small grant for a demonstration project for forestry and fuels work.

The Natural Resource Damages Trustee Council for California Gulch is looking to fund projects related to California Gulch and mining.

Jonathan is submitting a report to CDPHE for work following the Spring Creek Fire on Idlewild Creek.

Mark mentioned that the California Gulch projects include mitigating water quality issues from historic mining, road crossings over streets, forest management and wildfire risk reduction.

There will be a board meeting February 17th open to all Roundtable members.

PEPOW - Alli Schuch, Paul Fanning (meets on the 3rd Wednesday each month, at 1:30 pm)

There will be additional funding available for PEPO, and the team is looking at the new set of guidelines for PEPO grants.

Paul called for feedback on what PEPO could be working on.

The Water 22 kickoff will be happening soon, and the team is starting to look at the Water 22 mini tours.

Alli has continued work on the website, social media, and the Faces of the Watershed series.

Alli is also conducting the kickoff meeting to the Arkansas Basin Network involving folks across the basin to share resources and support one another.

Alli attended the Water Education Colorado Basin Brews meeting to involve Breweries in water education.

BIP Update – Lindsey Griffith

Lindsey reviewed the updates on the BIP and then reviewed some of the changes that may need to be made to the BIP including:

A statement from the 2015 BIP that "The Arkansas BRT finds that the current rate of purchase and transfer of water rights from irrigated agriculture is unacceptable." There was discussion on whether this is still the viewpoint of the Roundtable. Suggestions were made, including the removal of the sentence, taking more time to evaluate the statement, and a revised statement based on discussion of the Executive Committee: "The

Arkansas BRT finds that the purchase and transfer of water rights out of basin from irrigated agriculture is unacceptable." Alternatives were also suggested in the chat, "The Arkansas BRT is concerned that additional transfer of water rights from irrigated agriculture to other uses is undesirable and should be avoided if at all possible," from Paul Fanning, and "The Arkansas BRT is concerned that additional transfer of water rights from irrigated agriculture to other uses that results in permanent dry-up of irrigated agriculture lands is undesirable and should be avoided if at all possible and further recommends mitigation efforts to protect local economies if permanent transfers occur," from Jack Goble. Julie Knudson pointed out that a future statement could include economic and ecological impacts. Other suggestions include adding the context of the 2015 adoption of the statement.

The matter will be taken up for formal consensus in the February meeting.

Concerns were also raised about Appendix B, and whether the Arkansas Project List should be included in the BIP, since some of the projects are controversial. Language that expressed that the projects in the list are not necessarily endorsed by the Roundtable was suggested for addition.

PROGRAM

Beaver Park Water Inc. - Steve Kastner

This was a multi-year project to repair damages to the Beaver Park Water systems upper supply canal. The solution included replacing existing stream crossing flumes to increase canal capacity and removing and replacing 4,526 feet of failed canal lining. Thanks to the project going under budget another unlined section of the canal, "The Grand Canyon Cut," was added to the project for removal of trees, course straightening, and pipeline installation.

The meeting was adjourned at 2:53 pm.

1. Greetings and necessary introductions:

Mark called the meeting to order at 10:30AM stating that we had a quorum.

2. Minutes/Notes of Previous meeting:

Mark called for any comments or changes to the December 8, 2021 Executive Committee Minutes hearing none approved the minutes by consensus.

3. ARWC Matters:

• Executive Director Updates - Jonathan reported that ARWC has hired Margaret Strozyk as the new Fuels Mitigation Specialist she will be focusing on the Wet Mountains initially having secured grants for this area. He is also working on our upcoming ARWC Board meeting on February 17th. He will pass it on to Mark for distribution an before long. He has also been meeting with the natural resources damages trustee council regarding the California Gulch proposal that has been submitted. A report is being submitted to the CHE regarding the Idlewild project which is now complete. Monarch is now complete and a final invoice is being submitted. Mark added that several items will be discussed at our upcoming ARWC Board meeting including sustainable funding and Bylaw's review.

4. Reoccurring matters:

• Chair Comments – Mark Shea reported on previous meetings with water providers held in 2021 focusing on multiple year water quality initiatives that includes several of our Water Conservancy Districts in the Arkansas basin. The focus will be on water quality dashboards to better understand water quality issues. Mark asked if any questions regarding water quality issues with Steve Kastner commenting on the lower Ark presentation presented previous and Kansas concerns regarding water quality. Mark replied that several areas will be monitoring water quality with the most eastern several miles within the Kansas state line.

Outstanding Reports – Executive Committee Members Bob Hamel opened the discussion regarding Nebraska's funding several cannel projects on the South Platt focusing on improving their water availability. The issue being compact flows required for Colorado's delivery. Mark brought to Bob the Utah Railroad proposal and its effect on Brown's Canyon. Bob responded that this appears to be an ongoing issue.

5. **ABRT BIP Update** – Public Comment period ended November 15. Lindsey Griffith reported on the Public comments received prior to November 15th. Her edits to Vol's I &II should be completed by end of week. Her edits on the document should be ready by the scheduled Water Congress the end of January.

Lindsey has compiled BIP comments for other Basins to compare public reactions. Many of the comments received were observations and not necessarily changes to our BIP. One of the modifications to the BIP was Section 8 now referred to Education and Outreach for better clarity. Section 9 is changed to the BIP Executive Summary resulting from some of these comments. Many of these comments came from an organization called Water for Colorado. Bob Hamel asked for clarification regarding this organization. Jonathan posted that it appears to be a coalition of non-profits and community organizations.

Sandy White asked if this document and its modifications will be approved by the Roundtable and will that be a special meeting? Mark suggested that our next scheduled meeting February 9th may be a good date for approving. Terry Scanga agreed with Sandy's earlier comments on how a few projects are being listed that have not gone through the Roundtable but are listed anyway. Terry has concerns on approving the entire document as it currently being presented. Mark suggested approving Vol's 1 & 2 separately. Sandy suggested data base where these projects are listed should be separate from the state listed projects. Russ Sands suggested to add caveat language to clarify project not Roundtable projects.

Mark suggested we proceed to discuss Volume II. Lindsey stated this volume is developed mostly from our 2015 BIP. She has highlighted some of the statements that she felt could be updated for today's issues and concerns e.g. "water sharing" being misleading to today's environment. Other wording with how water used in agricultural areas as being not conducive for today. Several issues about agricultural water being transferred to non-ag use is penitent to some of today's concerns. Lindsey wrapped up the discussion on basically wording and whether or not include current basin projects in volume 2.

6. Roundtable Business:

- Demand Management Discussion
- Mark opened the discussion on our 2022 Program topics that Steve Kastner will be providing in
 our upcoming Roundtable General Sessions. Steve Kastner shared his list of ideas for topics of
 discussion in these meetings for 2022. Steve asked if any of us knew any subject matter experts
 on any of these topics. Terry suggested we add the Colorado River as it affects other basins and
 would like to have a knowledgeable person discuss what is happening with the Colorado River
 and its effect on our Basin. Bob Hamel suggested having the Arkansas River Cooperative which is
