Meeting Notes

## **Roundtable Business**

Betty Konarski called the meeting to order at 11:45 am. Members and visitors introduced themselves. Twenty nine (29) members were present. There are 41 active roundtable members at this time – 20 is a quorum.

Alan Hamel was recognized for receiving the President's award by Colorado Foundation for Water Education.

## **March minutes**

March minutes were approved by consensus.

## **Public Comment**

### **Kevin Lusk, CS Utilities and Twin Lakes Canal and Reservoir Company**

Mr. Lusk expressed the company's concern about the discussion that has been taking place around New Supply. Twin Lakes Canal and Reservoir Company was identified as an example of a concept to reduce existing diversions in exchange for the hope of a new supply project. While they understand that the example was hypothetical, they are concerned that others may seize the opportunity to capitalize on the mention of it in order to further other agendas. The company asks the Roundtable to publish a retraction or clarification that the example was used without the company's knowledge or approval.

The Executive Committee will be talking about this with the other Roundtable Chairs, and will be coming up with a response.

The example was used in a proposal to create a process for basin to basin discussion about potential solutions. In the example of how a process might work, the example included Twin Lakes. The reference was in our BIP draft of Section 4.8.

Jeris – For the first time in history, we are moving ahead on the issue of new supply, which has now been defined as a trans-mountain diversion. A dialogue has begun, to talk about eight points that came out of the March meeting.

Jay – The 8 Points

1. The East Slope is not looking for firm yield from a transmountain diversion project and would accept West Slope hydrologic risk for that project. Future West Slope needs will need to be accommodated as part of a new transmountain diversion project.
2. A transmountain project would be used conjunctively with ATMs, Denver Basin Aquifer resources, carry-over storage, terminal storage, drought restriction savings, and other non-West Slope water sources in order to firm up the water supply.
3. In order to manage when a transmountain diversion will be able to divert, triggers are needed.
4. An insurance policy is needed for existing uses, “agreed-to” projects, and some reasonable increment of future West Slope development.
5. Clarification is needed for how West Slope needs will be accommodated.
6. Colorado will continue its commitment to improve conservation and reuse.
7. Environmental resiliency and recreational needs must be addressed both before and conjunctively with a new transmountain diversion.
8. A project would have to include all of the above.

Alan – The last several meetings have been very productive when it comes to new supply. Jay and Jeris work hard on our behalf.

## **CWCB Report – Colorado Water Plan Progress**

CWCB met in mid-March. The principal focus of the meeting was the Colorado Water Plan. Public comment period has been extended. The CWCB is also feeling the time crunch. They committed to additional workshops in the months to come. A significant amount of CWCB’s work depends on the Basin Implementation Plans. More public input is being received.

The May meeting will be held in Pueblo at the Convention Center, on May 21-22. We encourage you to attend part of the meeting. We will send you the agenda as soon as it is produced. Any citizen or group can speak to specific agenda items during the meeting.

The Ark RT did get an award of \$59,000 to continue our Basin Implementation Planning process. All requests for Statewide Funding were tabled in March, because of the limitation of funds. Those requests will be considered in May, and include the grant request from Huerfano County WCD. If all statewide requests are approved, the statewide fund will be back down to around \$1,000,000. Going forward, requests for statewide funding will become more competitive, because funds are limited.

Severance Tax fund also benefitted the Ark Basin in March.

Gary and Mark discussed the elements of the BIP, and specific work completed to-date. RT members asked questions and discussed concerns and specifics.
